Re: California Public Records Act Request Dated December 30, 2020

Dear Mr. McMillan:

The County of Kings ("County") Registrar of Voters ("Registrar") received your Public Records Act (PRA) request dated December 30, 2020. On January 11, 2021, the County sent you a letter extending the initial response time to January 25, 2021. By agreement, the County's initial response time was further extended to February 26, 2021.

As indicated below, the County will require special assistance and expertise to extract and compile data that may be responsive to your requests. With respect to those categories of information, please let us know if you would like the County to begin the process of extracting and producing that data. Please note that the County will provide an initial estimate of the cost to extract the data and may require advance payment in connection thereto.

Additionally, some of your requests seek confidential security records the disclosure of which could reveal information that could be utilized in an attempted attack on the information technology systems of the County and Registrar. As such, the County intends to produce only records that cannot be used in an attempted cyberattack and those that do not increase the potential of a cyberattack.

Finally, several of your requests seek confidential voter registration information including voter history. Such information can be applied for and purchased pursuant to Election Code Sections 2188 and 2194 and the California Code of Regulations, title 2, section 19001, et seq., which among other things, require the submittal of an application form as specified in California Code of Regulations, title 2, section 19008. The information is only available for election, scholarly, journalistic, political or governmental purposes. Providing this voter registration information to any third party is prohibited under Title 2 of the California Code of Regulations Section 19005. As you are requesting this information on behalf of your client, you must provide the information stated in Elections Code Section 2188(c) including: (1) the name, mailing address, and telephone number of the person or organization on whose behalf you are requesting the voter registration information, and (2) the name of the person

authorizing or requesting you, the applicant, to obtain the voter registration information. A copy of the application to request voter registration information is included with this response.

Please find below the County's responses to your request in the same numerical format submitted to the County.

### **REQUEST 1:**

Provide those documents identifying, by date, time and means, all synchronization transmissions between the California Secretary of State and the county Registrar of Voters.

# **RESPONSE TO REQUEST 1:**

This request is vague and impermissibly overbroad in scope and time. Nevertheless, to facilitate a response, the County will treat your request as a request for synchronization transmission records related to the November 2020 election. Accordingly, the County will produce the Registrar's Statement of Registration Certifications related to the November 2020 election.

To the extent you are requesting other synchronization transmission records, the County does not retain a summary document identifying the date, time and means of all synchronization transmissions and possesses no other existing records that contain such information. However, the County may be able to produce additional records through data extraction, compilation or programming. Please let us know if you wish to have additional data extracted and compiled so that we may estimate the amount of costs associated thereto.

Additionally, any responsive documents identified hereunder that contain confidential voter registration information can only be produced after the Registrar receives and approves a completed application for voter registration, receives the applicable fee, and after the Registrar has had an opportunity to apply appropriate redactions.

#### **REQUEST 2:**

Provide those documents with the results of each synchronization transmission between the California Secretary of State and the county Registrar of Voters, by number of registrants confirmed as valid, and those that are identified as invalid.

#### **RESPONSE TO REQUEST 2:**

This request is vague and impermissibly overbroad in scope and time. Nevertheless, to facilitate a response the County will apply its best understanding subject to clarification. The County does not possess any existing records that contain the information requested. However, the County may be able to extract this information through data extraction, compilation or programming pursuant to Section 6253.9 of the Government Code ("Section 6253.9"). Please let us know if you wish to have this data extracted and compiled so that we may estimate the amount of costs associated thereto.

Additionally, any responsive document identified hereunder that contain confidential voter registration information can only be produced after the Registrar receives and approves a completed application for voter registration information, receives the applicable fee, and after the Registrar has had an opportunity to apply appropriate redactions.

# **REQUEST 3:**
