Good Afternoon Mr. McMillan,

This letter responds to your Public Records Act request received by the Placer County Clerk-Recorder-Registrar of Voters' Office on January 28, 2021. The request contained 63 categories of information relating generally to the November 3, 2020 General Election. On February 8th, the Clerk-Recorder-Elections Office requested additional time to prepare the response and indicated that a formal response would be provided by February 22, 2021. On February 22, 2021 that formal response was provided. Additionally,

To the extent that you seek additional information, the request submitted on January 28, 2021 seeks records which are, at least in part, disclosable public records. This office indicated that it was in the process of searching for, collecting, and appropriately examining a potentially voluminous number of records. As noted, certain categories of information required extraction or compilation, and others required submission of a voter registration information application. For the information requested that did not require extraction or compilation or an additional application, it was estimated that responsive information would be provided within thirty days, or by **Wednesday, March 24, 2021**.
