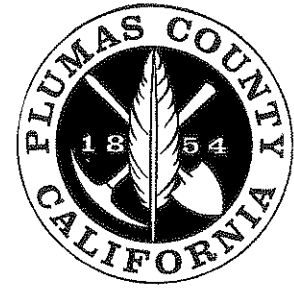

Re: Your Public Records Act Request, Which Was Received on February 1, 2021

Dear Mr. McMillian:

I am writing in response to the above-referenced Public Records Act request, which was received by Plumas County Registrar of Voters on February 1, 2021. The Registrar of Voters is reviewing your request and seeking responsive records. Pursuant to Government Code section 6253, subdivision (c), the County will need an extension of time to prepare its initial response.

Please note the County will not produce records that are privileged or otherwise exempt from disclosure. This includes documents pertaining to attorney-client privilege, attorney work product, office information privileges, and the election-related exemptions falling under Government Code §§ 6254(d) and 6255. If we determine any of these exemptions apply, we will inform you of those specific determinations.

After a review, my office has identified records responsive to your PRA request. However, pursuant to Government Code § 6253(c), subparts (2), (3) and (4), I have determined that there are unusual circumstances warranting an extension of time to assess when the records may be produced. I anticipate providing you an estimate to you on or before February 26, 2021. This extension is due to the need to search for, collect, and appropriately examine a voluminous amount of separate and distinct records that are demanded in a single request; the need for consultation with the County Counsel's Office and our IT Department, and the possible need to compile data, to write programming language or a computer program, or to construct a computer report to extract data.

information/dominion-voting. If you have trouble accessing this information at these sites, please contact our legal counsel, identified below and we will do all that we can to further assist you.

As for items 40-42 and 52, we have no responsive records. If you have any questions regarding this, please contact our legal counsel, identified below.

As referenced in your request, an application for voter registration information will be required for several of your inquiries, pursuant to Elections Code §§ 2187, 2188 and 2194, as well as 2 California Code of Regulations, §19001, et seq. Please find a copy of the application attached to this letter. Please return the completed application to the Plumas County Elections Department at 520 Main Street, Room 102, Quincy, CA 95971, along with the required \$50 fee.
