11. This request seeks security records exempt from disclosure per Government Code sections 6254(aa), 6254.19, and 6255 and 2 Cal. Code Regs. section 19064.

12. There were 17 laptops capable of accessing the Elections wireless network [wlan]. Due to the authentication method of wlan, any other wireless devices not in the Elections domain would not be able to authenticate to the network. Any further identification is exempt from disclosure per Government Code sections 6254(aa), 6254.19, and 6255 and 2 Cal. Code Regs. section 19064.

48. 15,829 ballots were determined through the adjudication process.
