Re: Public Records Act Request

Dear Mr. McMillan:

The Department of Voter Registration and Elections is in receipt of your Public Records Act request dated April 7, 2021. I have been designated by the Registrar of Voters to respond to that request. The records that you have requested require the Department to search for, collect and examine a large amount of records; require consultation with another agency; require consultation with another department of the County; and require the Department to compile data, write programming language or a computer program or to construct a computer report to extract data.

Accordingly, the Department will be unable to make a final determination of whether your requests seek copies of disclosable public records in the possession of the Department by April 17, 2021 (the 10th day from the Department's receipt of your request). The Department will respond to your request within 14 days from the above date, i.e., by May 1, 2021.
