July 13 – August 7	<p>CANDIDATE FILING PERIOD – ALL CANDIDATES</p> <p>Declaration of Candidacy and related candidate filing forms:</p> <p>Candidate’s statement of qualifications filing: Optional candidate statement (200 words or less), to be paid for at time of submission.</p> <p>Statements of Economic Interests (form 700): Economic interest report.</p> <p>Forms are obtained from and filed with the county elections office.</p>
August 8 - 12	<p>EXTENDED CANDIDATE FILING PERIOD - <u>IF INCUMBENT DOES NOT FILE</u> Open to persons other than the incumbent.</p>
August 8 - 17	<p>10 DAY CANDIDATE STATEMENT PUBLIC EXAMINATION PERIOD - Persons may view candidate’s statements or purchase copies at the elections office. Voters or the elections official may seek a writ of mandate requiring any or all of the materials to be amended or deleted.</p>
August 13, 11 a.m.	<p>RANDOMIZED ALPHABET DRAWING Determines order of candidate names on the ballot.</p>
August 13 - 22	<p>EXTENDED 10 DAY CANDIDATE STATEMENT PUBLIC EXAMINATION PERIOD, IF APPLICABLE</p>
September 8* - October 20	<p>WRITE-IN CANDIDATE FILING PERIOD - Write-in candidates for a voter-nominated or nonpartisan office must file their Statement of Write-in Candidacy and Nomination Papers with the county elections official.</p>
September 24 – October 13	<p>COUNTY VOTER INFORMATION GUIDE MAILED between these dates.</p>
October 5	<p>VOTE BY MAIL BALLOTS TO BE MAILED NO LATER THAN THIS DATE (permanent & all mail precincts)</p>
October 5 – 27	<p>VOTE-BY-MAIL BALLOT APPLICATION PERIOD</p>
October 19	<p>15 - DAY CLOSE OF REGISTRATION</p>
October 20 – November 3	<p>NEW CITIZEN AND CONDITIONAL VOTER REGISTRATION PERIOD</p>
November 3	<p>ELECTION DAY - Polls open at 7 a.m. and close at 8 p.m.</p>

	Tabulation will begin immediately upon close of polls at the Colusa County Clerk-Recorder Registrar of Voters Office and shall continue until all precincts are accounted for. Totals posted as they become available at http://countyofcolusa.org/elections .
November 5	OFFICIAL CANVASS - The official canvass begins.
November 20	DEADLINE TO RECEIVE MAILED, VOTE-BY-MAIL BALLOTS - Mailed ballots delivered through (bona fide mail service) postmarked before election day, or by the close of polls on election day and received up to 17 days after the election may be counted
December 3	OFFICIAL CANVASS COMPLETED - Certified statement of election results completed and submitted to the Board of Supervisors no later than this date.
